Discussion of Maywood Park Master Plan Process

POLICY ANALYSIS STATEMENT:

Blake Theisen from Parkitecture will be in virtual attendance and discuss the master plan process with the committee. Currently the Public Works Department has a Request for Proposals for preliminary engineering on the storm water component of the project, and the master plan will include two options, one with an open detention basin concept, and one with an underground vault similar to what was installed at Stone Bridge Park.

The following are assumptions based on preliminary engineering calculations on the storm water project:

- A large amount of the cotton wood trees will need to removed and a significant amount of dead ash trees in the current mountain biking area will need to be removed.
- The sidewalk that ends in the park from the Winnequah Rd project will be extend via a path/sidewalk through the park and connect to the current sidewalk coming into the park from Maywood Rd, and extend to Nichols Rd

Other Items to consider for the Committee:


- Expansion of the Mountain Bike path
- Access from Maywood School to the park (with assumption that an agreement will be in place for Parks & Rec to rent school for Out of School Time activities)
- Relocation/Replacement of playground
- Merits of year round restroom facility to support programs/general park use

STAFF RECOMMENDATION:

Director Anderson recommends that as a result of initial conversations of park amenities that we would consider and items the board would not consider, that Parkitecture develops (2) initial concept plans that would be released for public feedback/discussion before Parks Boards makes a decision on what to include in the final master plan.

Maywood Park is located on Winnequah Road adjacent to Maywood School and was established in 1939. Access is from Winnequah Road through an onsite, ten-stall parking lot. The park topography is predominantly flat. A drainage swale and a bermed bituminous basketball court provide some topographical relief in the park. Canopied by a mature stand of cottonwoods, Maywood Park evokes a woods-like quality. Current uses include picnicking, playground activities, basketball, nature trail, passive recreation, and a mountain bike trail.

POLICY ANALYSIS STATEMENT:

Discussion of changing the meeting times for Parks & Recreation Board Meetings from 6:30 PM to during normal work hours. Night meetings have historically been the norm, but given more flexibility on work from home and technology advancements to make Zoom/Teams meetings viable with the ability to record/live stream meetings, Director Anderson is requesting to discuss the pros/cons of changing the meeting times during normal work hours.

Options could include normal Park & Recreation Board meetings on the 2nd Tuesday of each month to be at

- a. 9:00 10:30 am
- b. 12:30 2:00 pm
- c. 3:00-4:30 pm

The goal would be to increase public participation/viewing at different times and also for staff/committee member work/life balance. Increasingly working parents juggle child care pickup, dinner, and extra-curriculars that make attending/participating in our meetings difficult.

STAFF RECOMMENDATION:

Director Anderson recommends one of the times listed above with the flexibility for night meetings that we anticipate a large amount of public input or a hearing for proposed plans/etc. Currently there are several committees/commissions that meet at 4:00 pm or earlier so there is precendent within the city for committee meeting times during the day.

§ 18-12. Park and Recreation Board.

A. Composition. The Park and Recreation Board shall consist of two Council members and seven citizen members. The Mayor and City Administrator shall be ex officio nonvoting members of the Board.

B. Appointments.¹

- (1) Council members. The Council members of the Board shall be appointed by the Mayor subject to confirmation by the Council. The Council members shall serve for a one-year term commencing the third Tuesday of April of each year or until their successors are appointed and confirmed by the Council. One of the Council members shall be designated by the Mayor to serve as Chair of the Board.
- (2) Citizen members. The seven citizen members shall be appointed by the Mayor, subject to confirmation by the Council. The terms of the citizen members shall be three years beginning the third Tuesday of April and shall be staggered so that not more than two such appointments are made annually.
- C. Duties and responsibilities. The Board shall have the following duties and responsibilities, which shall be advisory except as otherwise provided:
 - (1) To review and recommend to the Council policies necessary for the governance of the City parks and recreation facilities and programs, which shall take into consideration and attempt to provide for the social, physical and cultural well-being of the citizens of the City.
 - (2) To review and recommend to the Finance and Personnel Committee all budgetary, revenue and expenditure proposals relating to park and recreation facilities and programs.
 - (3) To review and recommend to the Community Recreation Director rules and regulations necessary for the effective management of the City parks and recreation facilities and programs.
 - (4) To perform such duties and have such responsibilities as the Council shall from time to time, by ordinance, resolution or by law, direct.
 - (5) The Park and Recreation Board shall be designated as the official tree governing committee to review and make recommendations regarding tree planting, maintenance, removal, landscaping and enforcement.²

§ 18-21. Meetings.

- A. Standing committees, commissions and boards. All standing committees, commissions and boards shall meet at least monthly at regularly scheduled days and times. Meetings shall be noticed by the City Clerk in accordance with Chapter 19, Wis. Stats. Special meetings may be called by the chair and any two committee, commission or board members upon written request therefor to the City Clerk.
- B. Nonstanding committees, commissions and boards; special boards and commissions; ad hoc committees. All nonstanding committees, commissions and boards; special boards and commissions; and ad hoc committees may meet on a monthly basis at regularly scheduled days or times or at the call of the chair. Meetings shall be noticed by the City Clerk in accordance with Chapter 19, Wis. Stats. Special meetings may be called by any two committee, commission or board members upon written request therefor submitted to the City Clerk.
- C. Quorum. Every commission, committee or board is deemed to have a quorum present for the purpose of transacting business if at least 51% of the total number of authorized voting members are present, unless this Code or statutes require a different quorum, in which case such provisions shall apply.¹
- D. Records and reports. Every commission, committee or board shall keep a written summary of its proceedings and shall file copies of same with the City Clerk.

POLICY ANALYSIS STATEMENT:

The Department is requesting to increase the number of events that beer can be sold at Park & Recreation Events for 2023. Biergartens are a popular attraction for social engagement in our residents, and this year we plan on having Biegartens every other Thursday from May – September at Schluter Park, with new programming at Grand Crossing Park along with other special events at various locations. This could include coordination with Friends of San Damiano or other groups for fundraisers where Parsk & Recreation Staff could sell beer. With rainouts and rescheduling, the department is asking for the recommendation of Parks & Recreation Staff to sell beer at city parks for no more than 30 days in the calendar year 2023 with the final dates/times to be determined by the Parks & Recreation Director with a monthly report submitted to the Parks & Recreation Board & City Council.

Attached is the draft event calendar of known events intended to be scheduled for the year.

STAFF RECOMMENDATION:

Anderson recommends to proceed with this request for the flexibility to plan and execute events during the calendar year.
